

# Domestic Violence Prevention Work Funding Application Pack

## **Key Information**

Funding Area: England & Wales Applications open: 5th September 2016 Applications close: 5th December 2016

#### What are we looking for?

Prevention workers are specialists who teach the importance of healthy relationships to 12-18 year olds. This can be done by going into schools and youth groups and running workshops, following up with one to one sessions where appropriate. It also includes training teachers on domestic violence and the steps they can take if they believe (or are disclosed to) that a student is being affected. We believe that funding these workers is a key part of preventing domestic violence.

We are looking to fund Prevention posts within established services or projects dedicated to helping victims of domestic violence or children. These projects must be able to demonstrate a need for the funding, either because a previous funding opportunity is no longer available or if this is a new post.

These services must have the capacity to deal with or adequately refer disclosures of domestic violence.

## How do we fund?

We believe that our grants should make a lasting impact and as such we don't believe in funding a role for less than two years.

We do however look for partner funders and ask you to apply to us where another funder has already been secured or will be secured. Priority will be given to applications that are able to demonstrate that a match funder has been secured.

We work with the posts that we fund in order to ensure that they are at their most effective. Should you need non-monetary help from us we will endeavour to help in any way that we can.

### What are the requirements for funding?

- The individual must have the previous experience to complete the role of a Prevention Worker.
- The individual must have a strong understanding of Domestic Violence.
- The individual will provide workshops, assembly sessions, small group sessions and one to one sessions on healthy relationships.
- The individual will be able to provide "train the teacher" sessions.

- The individual will be able to manage disclosures and refer these to the appropriate support service.
- The organisation must have the capacity to monitor the success of the role and fulfil relevant monitoring processes. Data should be sent to us on a quarterly basis.
- The organisation must show that match funding has been/or will be secured.
- The organisation has a track record of delivering effective projects to help victims of domestic violence and/or children.
- The post must have a supervisor who has the capacity to manage the post and ensure that:
  - ° Performance is monitored;
  - ° Safe working practices are adhered to; and
  - ° Further training and personal development of the individual is overseen.

Please note that we look to fund the prevention work, we will not be able to fund any research, management or monitoring associated with the role.

#### What is the application timetable?

You can apply for funding between the 5th September 2016 and the 5th December 2016. The deadline for receiving applications is 4pm on the 5th December 2016.

We know that each post is unique so if you are successful in the first instance you will be contacted from the 16th December 2016 and we will arrange to meet you in January to discuss your application further.

If you are successful in your application we will confirm this by the 1st March 2017 at the latest.

Our funding period is from April to April.

#### How do I apply?
